We are pleased to inform you that Oriana Power Limited (“Company”) has received Letter of Award (LOA) from **Solar Energy Corporation of India Ltd. (SECI)** under **SIGHT Scheme (Mode-2A-Tranche-I)** for **Production and Supply of Green Ammonia of 60,000 metric tonnes per annum (MT/Year) at the rate of 52.25(INR/Kg)** to Madhya Bharat Agro Products Limited-II located in Sagar, Madhya Pradesh (“Project”).

In addition, the Company will be eligible to receive incentives under Sight Program-Component-II (Incentive for procurement of Green Ammonia Production) under Mode-2A of the National Green Hydrogen Mission, as per the terms of the scheme.
