## REPORT OF SCRUTINIZER IN RESPECT OF POSTAL BALLOT E-VOTING

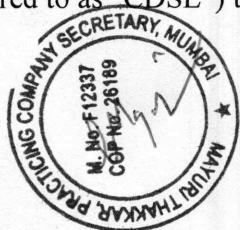
[Pursuant to Section 110 read with Section 108 of the Companies Act, 2013 and Rule 22 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended]

### 1. APPOINTMENT AS SCRUTINIZER

The Board of Directors of **ORICON ENTERPRISES LIMITED** (hereinafter referred to as the "Company") had appointed me as the Scrutinizer for the Postal Ballot E-Voting ("hereinafter referred to as E-voting") pursuant to Section 110 read with Section 108 of the Companies Act, 2013 ("Act") and other applicable provisions, if any, of the Act and Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014 ("Rules") including any statutory modifications or re-enactments thereof for the time being in force and other applicable provisions, Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations") and the Secretarial Standard on General Meetings issued by the Institute of Company Secretaries of India ("SS-2"), as amended from time to time, read with the General Circular Nos. 14/2020 dated April 8, 2020, and subsequent circular issued time to time by the Ministry of Corporate Affairs ("MCA") (hereinafter collectively referred to as "MCA Circulars", for the matter in respect of the resolutions as set out in the Postal Ballot Notice dated August 08, 2025 transacted by way of postal ballot E-Voting.

The notice published in the aforesaid Newspapers carried all the required information as specified in the said Rules.

### 3. CUT-OFF DATE

Voting rights were reckoned as on Friday, August 08, 2025 being the cut-off date for the purpose of identifying the entitlement of Members for E-Voting through Postal Ballot.

### 4. REMOTE E-VOTING PROCESS

- **Agency:** The Company had appointed NSDL as the Service Provider, for the purpose of extending the facility of E-voting to the Members of the Company through their website [www.evoting.nsd.com](http://www.evoting.nsd.com).
- **E-Voting period:** Remote E-Voting platform was open from 09:00 AM on August 18, 2025 till 05:00 PM on Tuesday, September 16, 2025 and the members were required to cast their votes electronically conveying their assent or dissent in respect of the Resolutions on the remote E-Voting platform provided by NSDL.





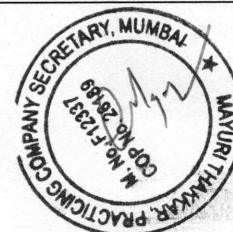
