Consequently now onwards they will issue their Audit Report/ Limited Review Report to our Company in name of Sarda & Pareek LLP.

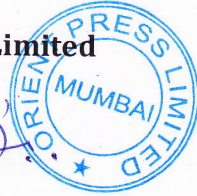

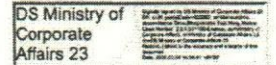
