Subject: Clarification on Discrepancy in EPS reported in the Financial Results

Dear Sir/Ma'am,

This is with reference to your aforementioned email to us wherein you have sought our clarification in response to the query raised. In this regard, please find below our response:

Query 1. Financial results submitted in XBRL with discrepancies-EPS mismatch in XBRL & PDF.

Reply 1: With reference to the captioned query, we would like to inform you that the outcome of the Board Meeting held on May 29, 2026 for approval of the financial results for the FY 2025-26 was filed within the prescribed timeline. However, due to an inadvertent typographical error, incorrect Earnings Per Share (EPS) figures were mentioned in the Standalone and Consolidated Financial Results for the Half Year ended March 31, 2026 (Audited) and the Financial Year ended March 31, 2026 (Audited) in both PDF filing as well as in XBRL.

Immediately upon identifying the above error, the Company took the necessary corrective steps. Since the Outcome tab on the NSE portal did not permit uploading a revised PDF after the initial submission (outcome letter dated May 29, 2026), the corrected PDF containing the revised EPS was uploaded under the General Updates tab on May 31, 2026. Further, the revised XBRL with the correct EPS figures was also submitted on the NSE portal on May 31, 2026.
