Congress lawmaker Shashi Tharoor, who has through his words and actions on multiple occasions caused discomfort to his party over the last year, again caused a flutter through an article that right on the eve of Bihar elections talked of "grave threat to Indian democracy" from "dynastic politics" – an issue BJP has been raising to attack the Congress and Rashtriya Janata Dal with.

He wrote in the article, published on October 31, that: "For decades, one family has towered over Indian politics. The influence of the Nehru-Gandhi dynasty - including independent India's first prime minister. Jawaharlal Nehru, prime ministers Indira Gandhi and Rajiv Gandhi, and current opposition leader Rahul Gandhi and MP Priyanka Gandhi Vadra – is bound up with the history of India's struggle for freedom. But it has also cemented the idea that political leadership can be a birthright. This idea has penetrated Indian politics across every party, in every region, and at every level."

Tharoor added that. "While the Nehru-Gandhi family is associated with the Indian National Congress, dynastic succession prevails across the political spectrum" the time has come to trade "dvnasty for meritocracy".

His article immediately provided an opportunity to the BJP to flog the Congress and the RJD for working to enrich their leading families.

BJP national spokesperson C.R. Kesavan saw Tharoor's views as "a veiled attack on the Nehru-Gandhi family's misrule which severely affected India's progress for decades."

कालू 25 दिन पहले ही विदिशा से इंदौर आया था और जबरन कॉलोनी में किराए का मकान लिया था। उसके परिवार में माता-पिता और तीन भाई हैं, जो खेती और मजदूरी करते हैं। पुलिस का कहना है कि जहां हादसा हुआ, वह इलाका ट्रेन हादसों के लिए जाना जाता है। स्टेशन के करीब होने से यहां ट्रेन की गति धीमी रहती है और अक्सर हॉर्न नहीं दिया जाता, जिससे लोग अचानक चपेट में आ जाते हैं। पुलिस यह जांच कर रही है कि यह
