**SUB: Consolidated Scrutinizer's Report on Remote E-Voting conducted pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended by Companies (Management and Administration) Rules, 2015 and Poll conducted at 2<sup>nd</sup> Annual General Meeting of Shreeoswal Seeds And Chemicals Limited held on Saturday, 14<sup>th</sup> September, 2019 at 3:00 P.M.**

1. I, L.N. Joshi, Practicing Company Secretary, has been appointed as a Scrutinizer by-

- (i) The Board of Directors of Shreeoswal Seeds And Chemicals Limited in their meeting held on 7<sup>th</sup> August, 2019 for the purpose of scrutinizing the Remote E-voting process under the provisions of Section 108 of the Companies Act, 2013 and Rule 20(4)(xii) of Companies (Management and Administration) Amendment Rules, 2015 in respect of the below mentioned resolutions transacted at the 2<sup>nd</sup> Annual General Meeting (AGM) of the members of the Company held on Saturday, 14<sup>th</sup> September, 2019.
- (ii) The Chairman of the 2<sup>nd</sup> Annual General Meeting (AGM) on poll under the provisions of Section 109 of the Companies Act, 2013 and Rule 21(2) of Companies (Management and Administration) Rules, 2014, on the resolutions contained in the Notice to the AGM of the members of the Company held on Saturday, 14<sup>th</sup> September, 2019.

2. The Notice dated 7<sup>th</sup> August, 2019 along with the statement setting out material facts under Section 102 of the Act were sent to the Shareholders in respect of the below mentioned resolutions passed at the AGM of the Company.

### 3. Cut-off Date

The voting rights were reckoned on Saturday, 7<sup>th</sup> September, 2019, being the cut-off date for the purpose of deciding the entitlements of members at the remote e-voting and voting at the meeting.

### 4. Remote E-Voting

#### 4.1 Agency:

The Company had availed the E-voting facility offered by Central Depository Services (India) Limited (CDSL) for conducting remote E-Voting by the shareholders.

#### 4.2 Remote E-Voting:

Remote E-Voting platform remained open from Wednesday, 11<sup>th</sup> September, 2019 (9.00 A.M.) up to Friday, 13<sup>th</sup> September, 2019 (5.00 P.M.) and members were given an option to cast their votes electronically conveying their assent or dissent in respect of the Ordinary/Special Resolutions, on the e-voting platform provided by CDSL.

### 5. Voting at AGM

5.1 As prescribed under Rule 20(4)(xiii) of the Companies (Management and Administration) Amendment Rules 2015, for the purpose of ensuring that members who have cast their votes through remote E-Voting do not vote again at the General Meeting, the scrutinizer shall have access after closure of period of remote e-voting and before the start of general meeting, to only such details relating to members who have cast their votes through remote e-voting, such as their names, folios, number of shares held but not the manner in which they have voted.

5.2 Accordingly CDSL, the E-voting agency provided me with the names, DP Id/ Folio Numbers and shareholding of the members who had cast their votes through remote e-voting.

5.3 Further, the chairman announced the poll at the Annual General Meeting for the shareholders who had attended the meeting and have not cast their vote earlier through remote e-voting.

### 6. RESULTS

6.1 I observed that

a) 12 members had cast their votes through remote E-voting.

b) No members had cast their votes through poll conducted at the meeting.


Based on the above information, you may kindly announce the result of voting by Poll at AGM and remote e-voting.

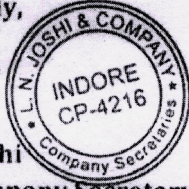


