This is with reference to the NSE Circular Ref No. NSE/CML/2019/11 dated 02.04.2019, we wish to inform you that in terms of Company's Code of Conduct to regulate, monitor and report trading in Company's Securities by Insiders framed under SEBI(Prohibition of Insider Trading) Regulations, 2015, the trading window for dealing in the Securities of Company will remain closed for all Designated Persons, their immediate relatives and connected persons (as defined in the Code) with effect from 1<sup>st</sup> July, 2024 for the purpose of consideration of standalone and consolidated Un-Audited Financial Results for the quarter ended on 30<sup>th</sup> June 2024.

This is further informed that the Company has also complied with the requirements of Securities and Exchange Board of India (SEBI) Circular No. SEBI/HO/ISD/ISD-SEC-4/P/CIR/2022/107 dated August 5, 2022 and SEBI/HO/ISD/ISD-PoD-2/P/CIR/2023/124 dated July 19, 2023, regarding Trading Window Closure period under Clause 4 of Schedule B read with Regulation 9 of SEBI (Prohibition of Insider Trading) Regulations, 2015 ("PIT Regulations") framework for restricting trading by Designated Persons ("DPs") by freezing PAN at security level.

The Trading Window shall open 48 hours after the standalone and consolidated Un-audited Financial Results for the Quarter ended 30<sup>th</sup> June 2024, become generally available.

Further, we are submitting the above said information in XBRL mode (excel template provided by Exchanges) along with the submission in PDF mode within prescribed time.

The date of Board Meeting for declaration of financial results of the Company for the quarter ended on 30<sup>th</sup> June 2024 will be intimated in due course.
