# पहले दिन ही हंगामा...गिरगिट के खिलौने लेकर पहुंचा विपक्ष

## हंगामे के बीच कार्यवाही मंगलवार तक के लिए स्थगित

भोपाल,(निप्र)। मध्यप्रदेश विधानसभा का मानसून सत्र सोमवार को शुरू हुआ लेकिन कुछ देर बहस के बाद सदन की कार्यवाही मंगलवार तक स्थगित हो गई। वंदे मातरम गान से सदन की कार्यवाही शुरू हुई। सत्र के शुरू होते ही कांग्रेस विधायकों ने विरोध-प्रदर्शन किया। कुछ देर के बाद सदन की कार्यवाही स्थगित कर दी गई।

मध्यप्रदेश विधानसभा के मानसून सत्र की शुरूआत राजनीतिक गर्मी और विरोध के साथ हुई। सत्र के पहले ही दिन सोमवार को कांग्रेस विधायकों ने ओबीसी आरक्षण के मुद्दे को लेकर सरकार के खिलाफ अनोखे अंदाज में प्रदर्शन किया। विधायक गिरगिट के खिलौने और तिख्तयां लेकर गांधी प्रतिमा के सामने पहुंचे और सरकार पर गिरगिट की तरह रंग बदलने का आरोप लगाया। हंगामे के बीच कार्यवाही मंगलवार 29 जुलाई तक के लिए स्थगित कर दी गई। कांग्रेस विधायकों ने नारेबाजी करते हुए आरोप लगाया कि सरकार ओबीसी वर्ग को 27 फीसदी आरक्षण देने के अपने वादे से बार-बार मकर रही है।

श्रद्धांजिल के बाद सदन की कार्यवाही स्थिगित- सत्र की शुरूआत विधानसभा अध्यक्ष नरेंद्र सिंह तोमर, मुख्यमंत्री डॉ. मोहन यादव और नेता प्रतिपक्ष उमंग सिंघार द्वारा दिवंगत नेताओं को श्रद्धांजलि अर्पण के साथ हुई। इनमें पूर्व विधायक राजा सुरेंद्र बहादुर सिंह, रघुनाथ चौधरी, शंकर लाल मुन्नाखेड़ी, सरदार सुखदेव सिंह, पूर्व केंद्रीय मंत्री डॉ. गिरिजा व्यास, गुजरात के पूर्व मुख्यमंत्री विजय रुपाणी, फिल्म अभिनेता मनोज कुमार और लोक कलाकार रामसहाय पांडे शामिल हैं।

भाजपा ने कांग्रेस के विरोध -प्रदर्शन को बताया ड्रामा- बीजेपी नेताओं ने कांग्रेस के इस विरोध प्रदर्शन को डामा करार दिया। सिरोंज से भाजपा विधायक उमाकांत शर्मा ने कहा. कमलनाथ जी को सदन में आने से कौन रोक रहा है? यह कांग्रेस की अंदरूनी गुटबाजी का नतीजा है। पिछोर से भाजपा विधायक प्रीतम सिंह लोधी ने कांग्रेस पर पलटवार करते हुए कहा, हम तो इंसान हैं, कांग्रेस खुद गिरगिट है। प्रधानमंत्री नरेंद्र मोदी ने जनगणना और ओबीसी आरक्षण की पहल कर दी है, कांग्रेस मुद्दा खो चुकी है।

वहीं उज्जैन के महाकाल मंदिर में दर्शन को लेकर गड़बड़ी के मामले पर बीजेपी विधायक चिंतामणि मालवीय ने दो टुक जवाब दिया कि वे सरकार का प्रवक्ता नहीं हैं। ये सवाल सरकार से

ओबीसी आरक्षण पर रंग बदलने का आरोप- कांग्रेस विधायक पंकज उपाध्याय, सोना पटेल और अन्य नेताओं ने आरोप लगाया कि सरकार जानबुझकर ओबीसी वर्ग के आरक्षण को कानुनी पेच में फंसा रही है और उनके अधिकारों से वंचित कर रही है। जोबट विधायक सोना पटेल ने कहा, हम भाजपा की सोई सरकार को जगाना चाहते हैं। वादे अधूरे हैं और सरकार गिरगिट की तरह रंग बदलती है। जौरा विधायक पंकज उपाध्याय ने आरोप लगाया कि सरकार ने कोर्ट में महंगे वकील खडे कर ओबीसी आरक्षण रोकने का प्रयास किया। कमलनाथ सरकार ने 2019 में यह निर्णय लिया था, लेकिन हाईकोर्ट में याचिकाओं के चलते यह मामला काननी प्रक्रिया में उलझ गया। वर्तमान सरकार ने कोर्ट में महंगे वकीलों की नियुक्ति कर मामले को मजबूती से रखने का दावा किया। लेकिन, विपक्ष का आरोप है कि सरकार खुद नहीं चाहती कि ओबीसी को पूर्ण आरक्षण मिले। उन्होंने कहा, कमलनाथ सरकार ने जो आरक्षण लागू किया था, हम उसे

# Mass shooting in Bangkok leaves 6 dead

A gunman shot dead five people at a food market in the Thai capital on Monday before committing suicide, according to media reports. The incident happened at

12.38 pm at the Or Tor Kor market, known for highquality fresh fruit and seafood. The dead included four security guards, the Bangkok

Post newspaper reported. The gunman was found dead on a bench inside the market building, dressed in a black T-shirt and camouflage shorts, the report quoted po-

lice as saving Police recovered an ID card



and a driving licence identifying the deceased as Noi Praidaen, a 61-year-old man from Khong district, Nakhon Ratchasima. Two women sustained injuries. Police said officers are investigating the motive behind the attack. Mass shooting incidents are not common in Thailand, but the country has seen several deadly incidents in recent years. In 2023, a 14-year-old boy killed two people and injured five in a shooting at a luxury shopping mall in the centre of Bangkok.
