- We have reviewed the accompanying statement of unaudited financial results of M/s. Veritaas Advertising Limited ("the Company") for the half year ended 30<sup>th</sup> September, 2024 ('the Statement'), attached herewith. The statement is being submitted by the Company pursuant to the requirement of Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the Regulation).
- 2. The Financials results have been prepared in accordance with the accounting Standards ("AS") as prescribed under section 133 of the companies Act, 2013 read with rule 7 of Companies (Accounts) Rules 2014 ï by the Ministry of Corporate Affairs and amendments thereof.

As the company is listed on EMERGE platform of NSE it has been exempted from the applicability of IND AS as per the provision to the Rule 4 of the companies 2 (Indian Accounting standard) Rules, 2015.

The figures for the corresponding previous period have been regrouped / reclassified wherever necessary, 10

- As the Company collectively operates only in one business Segment, business of and also consultancy of advertising, publicity, public relations, press relations and 4 mass communication, hence, it is reporting its results in single Segment. Therefore, segment disclosure is not applicable.
- The Figures of Hulf year ended 31st March 2024 are the balancing figures between audited figures in respect of the full financial year and the unaudited figures up 1 to the 30th September 2023 of the previous financial year.
- The Earnings per share is calculated on the weighted average of the issued share capital by the company. Half yearly EPS is not annualised and Earnings Per Share calculations have been restated for the previous year to give effect of bonus issue of shares only.
- The Company has completed its initial public offer (IPO) of 7,44,000 Equity shares of face value of Rs 10 each at an issue price of Rs 114/- per share amounting to 7 Rs 848.16/- Lakhs The equity shares of the company were listed on NSE EMERGE Platform (India Limited ("NSE EMERGE") on 21st May, 2024.
