# Shocked, but now it is forgotten chapter: CJI

NEW DELH

Chief Justice of India B R Gavai on Thursday said he and Justice K Vinod Chandran were shocked when a lawyer attempted to hurl a shoe at him on October 6, but the issue is a "forgotten chapter." In an unprecedented and shocking incident, a 71-year-old lawyer, Rakesh Kishore, took his shoe in his hand and tried to hurl it at the CJI on Monday.

The CJI made the observation during the hearing of a batch of pleas seeking review and modification of the Vanashakti judgement, which had prohibited the central government from granting retrospective or ex post facto environmental clearances to projects found violating environmental norms

"My learned brother (Justice Chandran) and I were very shocked with what happened on Monday; for us it is a for-

### Sex edu should be provided to children from younger age: SC

NEW DELH

Sex education should be provided to children from a younger age, and not Class IX onwards, the Supreme Court has said.

A bench of Justices Sanjay Kumar and Alok Aradhe said sex education should be part of the curriculum in higher secondary schools so that young adolescents are made aware of the hormonal changes that come with puberty.

"We are of the opinion that sex education should be provided to children from a younger age and not Class IX onwards. It is for the authorities concerned to apply their mind and take corrective measures, so that children are informed of the changes that happen after puberty, and the care and cautions to be taken in relation thereto," the bench said. The top court made the observations while granting bail to a 15-yearold boy accused of offences under sections 376 (rape) and 506 (criminal intimidation) of the IPC, and Section 6 (aggravated penetrative sexual assault) of the Protection of Children from Sexual Offences (POCSO) Act.

The apex court earlier directed his release on bail subject to terms and conditions to be fixed by the Juvenile Justice Board, noting that he was a minor.

### **Attackers** planned to kill us: Injured **Bengal BJP MP**

> In his first reaction to the deadly attack, West Bengal BJP MP Khagen Murmu said on Thursday that the attackers had actually planned to kill him and the BJP MLA Shankar Ghosh during their visit to the flood-affected area in Nagrakata of Jalpaiguri district.

Currently admitted to a private hospital in North Bengal's Siliguri, the BJP MP said that had they not got out of there, they would not have survived.

"There was a plan to kill us together. They even tried to drag us out of the car. They could not do it. If they had pulled us out, they would have crushed our heads with stones and killed us," the BJP MP said, who will undergo surgery on his face as his facial bones were broken following the stone attack.

Khagen On Monday, Murmu and Shankar Ghosh faced protests when they went to provide relief to the flood-affected area in Nagrakata in Jalpaiguri district.

A large number of people attacked the BJP leaders with sticks and shoes. Stones were picked up from the river and hurled at their car.

# Private jet skids off runway in Farrukhabad during takeoff

A private jet carrying top executives of a food processing company had a narrow escape on Thursday after it skidded off the runway seconds after takeoff from the Mohammadabad airstrip in Uttar Pradesh's Farrukhabad district.

Officials said the aircraft, en route to Bhopal, veered off course and skidded for nearly

400 metres before coming to a halt. All passengers and crew members escaped unhurt.

According to sources, preliminary findings suggest that low air pressure in the tyres could have caused the aircraft to lose control during takeoff. A detailed investigation has been launched to determine the exact cause.

On board the aircraft were Deputy Managing Director of Woodpecker Greenagri Nutrients Private Limited Ajav Arora, SBI Head Sumit Sharma, BPO Rakesh Tiku,

ister Yogi Adityanath for maintaining Dalit memorials built during her tenure while sharply criticising the Samajwadi Party (SP) for what she called its "double-faced politics".

Addressing a massive gathering in Lucknow on the 19th death anniversary of BSP founder Kanshi Ram, Mayawati acknowledged the Yogi

government's assurance that ticket revenue from visitors to Dalit parks and memorials would be used for their maintenance. "I wrote a letter to the chief minister requesting that the ticket money collected from visitors be used for upkeep. The BJP govern-

ment assured us that this money would not be diverted elsewhere and they kept their word. For this, our party is thankful to them,"

Her remarks, seen as an unusual gesture of appreciation towards the ruling BJP, created a political buzz across the state, prompting a swift reaction from the SP.

## US prez weighs his **Nobel Prize chances**

The White House pegged him as 'The Peace President' on Thursday, even as Donald Trump himself seemed sceptical about his prospects of winning the Nobel Peace Prize despite his claim of settling 'seven' global conflicts. The US President, who has repeatedly taken credit for brokering peace between India and Pakistan -despite New Delhi's denial -- has hinted that the Norwegian Nobel Committee "will find a reason" to not consider him for the global recognition that he believes should belong to him.

This came after Trump announced that Israel and Hamas have agreed to a deal for the first phase of a ceasefire in Gaza, after days of indirect talks in Egypt.

When asked by a reporter at the White House about his chances of winning the prize that is set to be announced on Friday, Trump said, "I have no idea... Marco (Secretary of State Rubio) would tell you we settled seven wars. We're close to settling an eighth. I think we'll end
