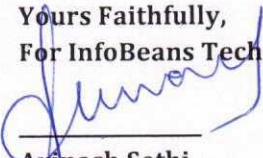

- 9.) Any other business as may be approved by the chairman.

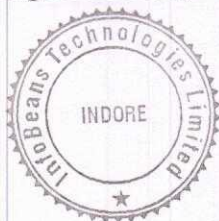
