Panache DigiLife Reports Robust Q1FY26 Results with 151% YoY Revenue Growth, 11397% PAT Growth

Mumbai, 8th August 2025: Panache DigiLife Ltd. (NSE: PANACHE) has reported a stellar start to FY26, registering a **151% YoY surge in revenue** to ₹29.54 crore in Q1FY26, as compared to ₹11.76 crore in the same quarter last year. **Net profit increased sharply to ₹0.91 crore, up from ₹0.08 crore**, reflecting a massive expansion in profitability with PAT growing at 11397%. This performance underscores Panache's ability to scale rapidly while improving profitability, backed by a growing order book, diversified customer base, and continued momentum.
