Sub: Update on Fire Incident under Regulation 30 and Regulation 51 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations").

Dear Sir/Madam,

Pursuant to Regulation 30 and Regulation 51 read with Schedule III of Listing Regulations and with reference to our disclosure dated August 19, 2025 regarding the fire incidence that took place at our yarn manufacturing premises situated at Village Koom Khurd, Jhalan Road, Koom Kalan, Ludhiana- 141126, Punjab, on August 18, 2025 at around 05.50 P.M. IST., we would like to inform that the Company has received an amount of Rs. 14,62,35,094.00 towards an on-account payment for loss of property, plant and equipment from the Insurance Company, yesterday i.e. September 17, 2026, based on recommendation given by the surveyors in their interim report.

The assessment and settlement of the insurance claim in respect of the loss of property, plant and equipment and other assets at the yarn manufacturing premises, loss of profit arising from business interruption, and reinstatement value of assets have been undertaken. The Company has received an on-account amount of Rs. 14,62,35,094.00 towards the insurance claim to date. The balance amount of the insurance claim, as determined and payable by the insurer, is expected to be received in due course.

Further details as required under Regulation 30 of the Listing Regulations read with SEBI Master Circular No. HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated January 30, 2026, ("SEBI Circular"), is enclosed as Annexure A.

Details as per SEBI Circular

1	Insurance amount claimed and realized by the listed entity for the loss/damage;	The Company has claimed an insurance amount of Rs. 15,42,59,666 against the loss/damage arising from the fire incident. Out of the claimed amount, Rs. 14,62,35,094 has been realized by the Company, while the balance amount remains pending for realization.
2	The actual amount of damage caused due to the natural calamity or other force majeure events.	The Company has recognised a loss of Rs. 20,76,08,511.48 on account of damage to certain Property, Plant and Equipment, inventory and incidental charges. Against the said loss, the Company has raised an insurance claim amounting to Rs. 15,42,59,666. As at the date of this report, the Company has received Rs. 14,62,35,904 from the insurance company towards settlement of the claim. The balance amount of the insurance claim, as determined and payable by the insurer, is expected to be received in due course. Further, the Company has received Rs. 86,66,772.00 towards the sale of salvaged scrap.
3	Details of steps taken to restore normalcy and the impact of the natural calamity/other force majeure events on production or service, financials of the entity.	The fire incident at the Company's yarn manufacturing facility was promptly brought under control with the assistance of the local fire authorities and the Company's internal firefighting mechanisms, with no human casualty or injury. Subsequent to the incident, the Company has undertaken necessary measures for assessment of the damage and restoration of the affected production capacity. The Company is undertaking rebuilding and reinstatement of the affected facilities and has taken necessary steps towards procurement and installation of machinery and other required assets for restoration of operations. The incident was confined to the yarn manufacturing facility, while the Company's fiber manufacturing facility remained unaffected. The Company has undertaken necessary measures to minimise operational disruption and facilitate restoration of normal operations
