This is further to our stock exchange intimation dated 1<sup>st</sup> May, 2024 intimating about an order being issued by the Assistant Commissioner, GST (Central Tax), Sangareddy Division confirming a demand of Rs. 27,94,167/- (Indian Rupees Twenty seven lakhs ninety four thousand one hundred and sixty seven) as tax with applicable interest & penalty of Rs. 2,79,416/- (Indian Rupees Two lakhs seventy nine thousand four hundred and sixteen) during the period April 2018 to March 2019 & April 2020 to March 2021.

Pursuant to Regulation 30(7) of the SEBI Listing Regulations, this is to inform that pursuant to the Company preferring an appeal against the said order, the Additional Commissioner of Appeals II, Office of the Commissioner Appeals of Customs & Central Tax Appeals II Commissionerate, Hyderabad has issued an order with revised demand of Rs. 2,35,741 (IGST- INR 53147, CGST-INR 91297, SGST- INR 91297) along with applicable interest and penalty under section 73 of the CGST Act, 2017, thereby granting partial relief to the Company.
