II. Access to KFin e-voting system in case of members holding shares in physical and non-individual members in demat mode.

Members whose e-mail IDs are registered with the Company / DPs, will receive an e-mail from KFin which will include details of E-Voting Event Number (EVEN), USER ID and password. They will have to follow the following process:

- i. Launch internet browser by typing the URL: :: KFintech eVoting System Login :: .
- ii. Enter the login credentials (i.e., User ID and password). In case of physical folio, User ID will be EVEN (E-Voting Event Number) xxxx, followed by folio number. In case of Demat account, User ID will be your DP ID and Client ID. However, if you are already registered with KFin for e-voting, you can use your existing User ID and password for casting the vote.
- iii. After entering these details appropriately, click on "LOGIN".
- iv. You will now reach password change Menu wherein you are required to mandatorily change your password. The new password shall comprise of minimum 8 characters with at least one upper case (A- Z), one lower case (a-z), one numeric value (0-9) and a special character (@,#,\$, etc.,). The system will prompt you to change your password and update your contact details like mobile number, e-mail ID etc. on first login. Further in accordance with the applicable provisions of the Companies Act, 2013 ('the Act') and SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015 ('SEBI LODR Regulations') which, among other things, require every listed company to have at least one woman director on its Board and pursuant to the first proviso to Regulation 17(1E) of SEBI LODR Regulations if the vacancy in the Board is due to expiration of the term of office of any Director, the resulting vacancy shall be filled by the listed entity not later than the date such office is vacated.

Accordingly, to broad base the Board of the Company and to comply with the aforesaid provisions of law, the Board of Directors of the Company, based on the recommendation of the Nomination and Remuneration Committee, at their meeting held on 10th November, 2025, appointed Mrs. Shailaja Nair (DIN: 11343122) as an "Additional Director" in the capacity of Non-Executive Independent Director of the Company for a period of 5 years with effect from 14th November, 2025 to 13th November, 2030, under Section 161 of the Act, subject to approval of the Members of the Company.

Mrs. Shailaja Nair has also confirmed that she is not aware of any circumstances or situation, which exist or may be reasonably anticipated, that could impair or impact her ability to discharge her duties with an objective independent judgement and without any external influence. In the opinion of the Board, Mrs. Shailaja Nair fulfils the conditions as specified in the Companies Act, 2013 and the Rules framed thereunder and SEBI LODR Regulations and her independence of the management for appointment as a Non-Executive Independent Director of the Company.

Given her experience, the Board considers it desirable and in the interest of the Company to have Mrs. Shailaja Nair on the Board of the Company and accordingly, the Board recommends the appointment of Mrs. Shailaja Nair as a Non-Executive Independent Director, as proposed in the Special Resolution of the accompanying Notice for approval by the Members.
