We wish to inform you that, as part of the ongoing initiative to streamline the corporate structure of the PDS Group by eliminating non-operational and redundant entities and in accordance with Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), Design Arc LLC ("Design Arc, USA"), a step-down subsidiary of the Company in the State of Delaware, USA has been dissolved effective July 13, 2026, and the same was informed to the Company today i.e., on July 15, 2026.

Consequently, Design Arc, USA has ceased to be a step-down subsidiary of the Company.

Please note that the above transaction does not have any material impact on the Company's financial position, as Design Arc, USA did not have any active business operations.
