We wish to inform you that, as part of the ongoing initiative to streamline the corporate structure of the PDS Group by eliminating non-operational and redundant entities and in accordance with Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), Brand Collective BCPT, Unipessoal LDA, a step-down subsidiary of the Company in Portugal ("Brand Collective, Portugal"), has been dissolved with effect from February 11, 2026. The Company received the relevant information confirming the dissolution on February 26, 2026.

Consequently, Brand Collective, Portugal has ceased to be a step-down subsidiary of the Company.

Please note that the above transaction does not have any material impact on the Company's financial position, as Brand Collective, Portugal did not have any active business operations.
