SUMMARY OF PROCEEDINGS OF THE 54th ANNUAL GENERAL MEETING OF PEARL POLYMERS LIMITED

The 54th Annual General Meeting ("Meeting") of the members of the Company held on Monday, September 22, 2025 through Video Conferencing/Other Audio Visual Means, commenced at 12:30 P.M.
