**Query: Financial Results submitted in XBRL with discrepancies: - Half yearly Figures not submitted in XBRL**

This is with respect to clarification sought vide your mail dated 12<sup>th</sup> January, 2026, for non-filing of Half-Yearly figures in XBRL for financial results submitted for Quarter and half year ended 30<sup>th</sup> September, 2025 on the portal on 08<sup>th</sup> November, 2025. We clarified vide our reply dated 13<sup>th</sup> January, 2026 uploaded on NEAPS Portal, that while uploading the financial results in XBRL, the Company selected the Option 'Quarterly' and uploaded Unaudited Financial Results for the quarter as well as half year ended on 30<sup>th</sup> September, 2025. The said results are available on NEAPS and you may confirm from your Portal. If we had selected the option 'Half Yearly' while uploading results in XBRL, the portal would not allow us to upload 'Quarterly Results'.

We again received your mail dated 23<sup>rd</sup> January, 2026 on the captioned matter. On discussion, we were advised to upload revised financial results by selecting 'Half Yearly' in XBRL. When we tried to upload the same on portal, we were getting error that we need to first file the outcome in PDF by selecting option half yearly on NEAPS portal, so that the portal would allow us to upload 'Half Yearly Results' in XBRL mode. We reported this error to NSE on 23<sup>rd</sup> January, 2026 and requested to resolve the issue.

After discussion, you vide your mail dated 27<sup>th</sup> January, 2026, directed us to 'first submit the Outcome of Board Meeting-Financial Results with correct Period Type, then, submit the Integrated Filing-Financial (XBRL) accordingly in Half-Yearly option.'

Now we have submitted the Outcome of Board Meeting held on 8<sup>th</sup> November, 2025 by selecting first half year ended 30<sup>th</sup> September, 2025 and also uploaded financial results for the half year ended 30<sup>th</sup> September, 2025 on NEAPS in XBRL.

We request you to take our clarification on record and close the query.
