We hereby inform under the captioned Regulations that the Company has received on **05.12.2025** a communication from BSE Limited which has confirmed the levy of fine of Rs. 8,40,000/- (excluding GST @ 18%) by rejecting the Company's request for waiver of fines (citing valid grounds) dated **05.08.2025** which was filed pursuant to receipt of an email from the BSE regarding levying of the fine amounting to Rs. 8,40,000/- (excluding GST @18%) dated **31.07.2025** for non-compliance of Schedule XIX – Para (2) of the SEBI (ICDR) Regulations, 2018.

It is clarified further that the said delayed compliance, has not resulted in any detriment, injury or adverse effect to any shareholder/investor/market participant/operations.

The Company will comply and discharge the said obligation and also continue to pursue simultaneously taking up with available appropriate authority/s its efforts by way of appeal / application for waiver.
