Dear Sir, Madam,

In continuation of the Company's disclosure dated 10th June 2025 regarding the ongoing proceedings before the Hon'ble High Court of Bombay, it is hereby informed that Perfect Infraengineers Limited has challenged the orders of the Hon'ble NCLT, Mumbai dated 15th July 2024 and 29th October 2024, which admitted the Company into the Corporate Insolvency Resolution Process (CIRP).

The challenge has been filed on the ground that the Company was denied its statutory rights of revival and rehabilitation benefits as mandated under the MSMED Act of Parliament, in respect of actions taken by ICICI Bank.

The Hon'ble High Court of Bombay, by its order dated 16th September 2025, directed that "**status quo**" be maintained until the Court hears the Company's plea in detail. Further, by its subsequent order dated 29th September 2025, the Hon'ble Court extended the said interim order, directing that the interim reliefs shall continue.
