4.	Pricing Formula /Exercise Price	Under this Plan, the exercise price has been decided on the basis of Market price. However, the Exercise Price shall not be less than the par value of the Equity Shares of the Company. Accordingly, the exercise price was determined for 2,500 options at Rs. 300/- per Option.

5.	Options vested/ Vesting Schedule	The options granted shall vest not before one year and not after maximum period of two years from the date of grant.
6.	Time within which option may be Exercised	All Options upon vesting shall be exercisable during the Exercise period of 4 (Four) years.

The Options granted shall vest from the date of grant as per vesting schedule as approved by the Nomination and Remuneration Committee. All Vested Options shall be respectively exercised in one or more tranches during the Exercise period of 4 (Four) years. The exercise price shall not be less than the face value and shall not be more than Fair Market Value (FMV) of an equity share of the Company at the time of grant of option as determined by the committee from time to time and shall be in conformity with the applicable accounting policies, if any. Accordingly, the exercise price was determined for 2,500 options at Rs. 300/- per Option.
