## PhantomFX completes acquisition of Tippett Studio and Redefines the Global VFX Game

This acquisition is timely considering the VFX industry is at an inflection point after facing headwinds in 2024. **Phantom has grown organically at a CAGR of 66% in the last 3 years** (FY22-25). Now, with this partnership, combining Tippett's **40-year creative heritage** with Phantom's agility, scalability, and global cost advantage, it opens doors to the biggest clients and closes the loop on creative excellence.

## Why Tippett? Why Now?

The acquisition comes at a pivotal moment in the global content landscape. OTT giants like **Netflix**, **Disney+**, and **Amazon** are spending record amounts on immersive, effects-heavy content. Virtual production, AI tools, and real-time rendering are reshaping post-production pipelines. Global production is bouncing back from strikes. In short — the industry is accelerating, and only the nimblest players will scale with it.

Instead of waiting to earn trust in high-stakes markets like Hollywood, PhantomFX has fast-tracked its access through **Tippett's name, talent, and credibility**. With Marvel Studios and already onboarding projects, the strategy is working.

Tippett continues to operate as a **distinct brand under the Phantom Group**, retaining its key creative supervisors and Phil Tippett himself. At the same time, **Phantom has begun integrating Tippett's proprietary creature animation pipelines into its broader service structure** — especially in fantasy, sci-fi, and CG character-driven content.

Phantom's global network now looks like this:

- Tippett Studio (USA): Creative front-end, client access, creature animation expertise
- Phantom India: High-quality, cost-efficient production and creative execution hub
- China: Asia-Pacific delivery engine with having possibility of generating potential additional revenue of \$20M annual
- **Spectre Post:** High-volume roto, paint, and prep for global outsourcing and creative work for Low budget Shows globally.

This structure gives PhantomFX a 24/7 pipeline — capable of **end-to-end production across geographies and formats**, from commercials to Hollywood tentpoles.

# Profitable Synergy: High Margins, High Impact

The acquisition is not just strategic — it's profitable.

Tippett delivered revenue of USD 7 mn (INR 60 Crores) approximately with PAT of 22% in calendar year 2024, with a strong order book for 2025.

With **Tippett's consolidation from July'25**, Phantom is poised to demonstrate strong growth with **inorganic growth alone estimated at 65-70% and potential for strong margin accretion**.

This margin strength comes from Phantom's ability to leverage:

- India's skilled but cost-effective labor pool
- Automated, Al-enhanced production workflows
- Remote-enabled global collaboration
- Tippett's pricing power will lead to higher realisations and margins
- Tippett's reputation in Hollywood will improve working capital cycle
- **Studios**: India, USA, China
- Clients: Marvel Studios, Netflix, Amazon, Disney+ and more
- Order Book: Expanding rapidly across regions

Phantom has built a globally distributed pipeline that balances premium branding with efficient delivery. Where legacy Western studios often struggle with overhead and scale, Phantom has created an agile, hybrid structure. **Tippett becomes the high-value brand face** — Phantom powers the engine behind it.

- A door-opener in elite markets
- A platform to enter high-stakes bidding for global projects

Phantom has identified another award-winning European VFX studio for acquisition, with sizeable revenues. Once deal is concluded, this will place Phantom among the top-tier independent VFX networks globally, with deep regional penetration and creative brand diversity.

Further, Phantom is investing in:

- Al-powered tools for rotoscoping, matchmoving, and digital doubles
- Virtual production integration using Unreal Engine and camera tracking
- Animated IP development (building future revenue assets)
- Game cinematics and hybrid storytelling for newer platforms
