In Compliance with regulation 30 read with Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Board of Directors in their meeting held on Tuesday, March 10, 2026 which was commenced at 10:50 A.M. and Concluded at 11:20 A.M. decided to allot 4,84,600 (Four lakh eighty four thousand six hundred) Equity Shares upon conversion of warrants to Promoter and Non-Promoter at the price of Rs. 83.75/- including premium of Rs. 73.75/- per share on preferential basis.

Consequent to the aforesaid allotment, the paid-up equity capital of the Company has increased from Rs. 19,48,64,300/- consisting of 1,94,86,430 Equity Shares of Rs. 10/- each to Rs. 19,97,10,300/- consisting of 1,99,71,030 Equity Shares of Rs. 10/- each.
