Subsequently, pursuant to Regulation 7(2)(b) of Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations, 2015, the Company has made disclosure of the same to National Stock Exchange of India Limited (NSE) vide application no. 92290 on 15.03.2023.

Further, this is to inform you that Mr. Amit Mehta have acquired 1756 shares on 08.03.2023, 626 shares on 09.03.2023, 82 shares on 10.03.2023 and 760 shares on 13.03.2023 resulting a total of 3224 Equity shares of The Peria Karamalai Tea & Produce Company Limited (Target Company) at a total value of Rs.10,23,223 through on market purchase.
