(IST) through video conferencing ("VC")/Other Audio Visual Means ("OAVM") in compliance with and as per the circulars issued by the Ministry of Corporate Affairs and the Securities and Exchange Board of India.

2. Brief details of items deliberated and results thereof

2.1 Brief summary of the proceedings and the details of items deliberated

The requisite quorum being present, Mr. Lakshmi Niwas Bangur, Chairman of the Company welcomed all the Members, Directors and KMPs present at the AGM. He also informed that Representative of M/s. The Chairman further informed that in compliance with the provisions of the Companies Act, 2013 and the SEBI Listing Regulations, the Company has provided remote e-voting facility to its Members, to transact the business set out in the Notice of 109th AGM. The said facility was available from 21st September, 2022 at 9.00 a.m. till 23rd September, 2022 at 5.00 p.m.

Members who have joined the meeting through VC/OAVM and who had not cast their vote through remote e-voting, were provided the option to vote through e-voting facility made available at the AGM.

M/s. Vinod Kothari & Company, Practicing Company Secretaries are the Scrutinizer to scrutinize the remote e-voting process as well as for the e-voting at the AGM in fair and transparent manner.

Thereafter, the following businesses were transacted at the AGM:

1. Adoption of Standalone and Consolidated Annual Audited Financial Statements for the year ended 31st March, 2022 including the Balance Sheet as at 31st March, 2022 and Statement of Profit and Loss for the year ended on that date and the Reports of Board of Directors and Auditors thereon.
2. Declaration of Dividend on Equity Shares of the Company for the financial year ended March 31, 2022.
3. Re-appointment of Mr. Shreeyash Bangur (DIN 00012825), as a Director of the Company, liable to retire by rotation.
