Pursuant to Regulation 30 read with SEBI Circular No. SEBI/ HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated January 30, 2026, and any other applicable provisions of the SEBI Listing Obligations and Disclosure Requirements) Regulations, 2015 ("**Listing Regulations**"), PNC Infratech Limited (Company or PNC) is pleased to inform you regarding publication of an arbitration award in favour of the Company for an amount of **Rs. 244,09,35,262/-** (Rupees Two Hundred Forty-Four Crore Nine Lakh Thirty-Five Thousand Two Hundred Sixty-Two Only) by the Arbitral Tribunal on July 31, 2026, late evening during a hearing held in New Delhi in connection with an EPC project executed by the Company for UPPWD in the past. Certain disputes arose between the Parties during the execution and accordingly, upon invocation of arbitration provision of the Contract Agreement, the aforementioned Arbitral Tribunal (Tribunal) constituted for adjudication of the disputes. Upon adjudication, the Tribunal published the award on 31.7.2026

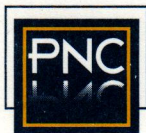
