The standalone financial results of P N Gadgil Jewellers Limited (the "Company") have been prepared in accordance with the recognition and measurement principles laid down in the Indian Accounting Standard, prescribed under Section 133 of the Companies Act, 2013 ("the Act") read with relevant rules issued thereunder and other accounting principles generally accepted in India and in terms of Regulation 33 of the Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.
3. The Chief Operating Decision Maker ("CODM") of the Company examines the performance from the perspective of the Company as a whole viz. Jewellery business' and hence there are no separate reportable segments as per Ind AS 108 "Operating Segments".
4. The figures for the quarter ended 31st March 2026 are balancing figures between audited figures in respect of financial year ended 31st March 2026 and published year to date figures for nine months ended 31st December 2025, which were subjected to limited review by the statutory auditor.
5. The provision for employee benefits expenses for the quarter ended on June 30, 2026 have been provided on the basis of management's estimates, instead of actuarial valuation as required by the IND AS 19- Employee Benefits. However, in the opinion of the management, the impact thereof will not be material.
6. The comparatives for the prior quarters or year have been regrouped / reclassified wherever necessary to conform with the current quarter / year classification. The impact of such regrouping / reclassifications are not material to these standalone financial results.

1.
