The SCN proposes demand of GST aggregating to ₹2,35,45,724/- along with applicable interest and penalty.

Details of violation(s)/ contravention(s) committed or alleged to be committed	The SCN alleges: (i) short-payment of GST of ₹16,41,145/- on account of alleged non-fulfilment of conditions prescribed under Notification No. 40/2017-Central Tax (Rate) dated 23rd October, 2017 and Notification No. 41/2017-Integrated Tax (Rate) dated 23rd October, 2017 in respect of certain supplies made to merchant exporters at concessional rate; and (ii) short-payment of GST of ₹2,19,04,579/- on account of alleged short declaration of quantity of black granite blocks dispatched during FY 2020-21 and FY 2021-22. The SCN further proposes applicable interest and penalty under the relevant provisions of the CGST/APGST Acts, 2017 and the IGST Act, 2017.

Impact of financial, operation or other activities of the Listed entity, quantifiable in monetary terms to the extent possible	The SCN proposes GST of ₹2,35,45,724/- and an equivalent penalty of ₹2,35,45,724/-, aggregating to ₹4,70,91,448/-, besides applicable interest. The aforesaid amounts are proposed demands under the SCN and are not final liabilities determined against the Company. Based on the advice of its legal advisors, the Company is examining the allegations and intends to contest the proposed demand by submitting its detailed response
