Details of the violation / contravention(s) committed or alleged to be committed	<p>The Income Tax Authority, vide assessment order passed under Section 143(3) of the Income Tax Act, 1961 ('the Act') received on 3rd March 2026, had made certain disallowances and additions aggregating to Rs. 41.87 crores. Pursuant to the said order, a demand of Rs. 327.45 Crores has been raised vide notice of demand issued under Section 156 of the Act.</p> <p>However, Income Tax Authority in the aforesaid order made certain computational / clerical errors, against which the Company filed a rectification application under Section 154 of the Act. Consequently, the Company has received a rectification order from the Income-tax Department, pursuant to which the aggregate income-tax demand has been reduced to ₹57.58 crore from ₹327.45 crore.</p>
Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible	<p>The Company, in consultation with its tax advisors, is of the opinion that the revised income tax demand ₹57.58 crore is still due to certain non granting of advance tax credit, which is rectifiable under section 154 of the Act. Accordingly, the Company has initiated the process for filing application for rectification before the jurisdictional Assessing Officer.</p> <p>Further, the Company, in consultation with its tax advisors, is of the opinion that the tax demand raised pursuant to the above-referred assessment order is not sustainable in law.</p> <p>The Company is process of filing appeal against the additions made in the said order under the applicable provisions of the Income-Tax Act, 1961.</p> <p>The Company does not expect any material impact on the financials position or operations on account of the said order.</p>
