We refer to our letter dt.22.08.2023 filed with Stock Exchanges, disclosing the details of pending litigations or disputes which may have an impact on the company.

In furtherance to the above, we wish to inform that the Appellate Tribunal for Electricity (APTEL) vide its order passed on 03.09.2025 has allowed the batch of appeals filed by our company challenging orders issued by Tamil Nadu Electricity Regulatory Commission (TNERC) fixing tariff for sale of electricity.
