Sub: Disclosure under Regulation 30 of SEBI (LODR), Regulations, 2015 - Receipt of Demand Cum Show Cause Notice from Additional Commissioner of GST and Central Excise

Pursuant to Regulation 30 of SEBI (LODR), Regulations, 2015, we hereby inform that the Company has received a demand cum show cause notice dated 28.04.2026 from Additional Commissioner of Goods and Services Tax (GST) and Central Excise alleging contravention by the company to the provisions of CGST Act, 2017/TNGST Act, 2017 in relation to wrong availing of Input Tax Credit on the Co-Generation Power Plant and other services and non-payment of GST on certain services.

In the view of the company, the demands raised in the show cause notice are not legally tenable. The company would give appropriate reply to the show cause notice and take appropriate legal recourse, as required.
