In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that Power Grid Corporation of India Limited, pursuant to its selection as the successful bidder under Tariff based competitive bidding, has on **29.07.2026** acquired **Bhadla Ramgarh Power Transmission Limited**, the Project SPV to establish Inter-State Transmission system for “**Augmentation at Bhadla-III, Ramgarh PS and Kanpur (PG)**”, on build, own, operate and transfer (BOOT) basis from the Bid Process Coordinator – REC Power Development and Consultancy Limited (RECPDCL).

The project comprises augmentation and bay extension works at Bhadla-III S/S (Rajasthan), Ramgarh S/S (Rajasthan) and Kanpur S/S (Uttar Pradesh).

Brief details of any governmental or regulatory approvals required for the acquisition;	Bhadla Ramgarh Power Transmission Limited was incorporated on 08.05.2026 by the Bid Process Coordinator as per the “Guidelines Encouraging Competition in Development of Transmission Projects” and “Tariff based Competitive-bidding Guidelines for

		Transmission Service" notified by Ministry of Power (MoP). Requisite approvals were obtained by the Bid Process Coordinator for transfer of Bhadla Ramgarh Power Transmission Limited. Approvals for Grant of Transmission License and Adoption of Transmission Charges are to be obtained from Central Electricity Regulatory Commission by Bhadla Ramgarh Power Transmission Limited after the acquisition by POWERGRID.
6.	Indicative time period for completion of the acquisition;	Bhadla Ramgarh Power Transmission Limited was acquired as per the timelines furnished by Bid Process Coordinator.

Cost of acquisition and/or the price at which the shares are acquired;	Bhadla Ramgarh Power Transmission Limited was acquired for an aggregate value of about Rs. 12.86 Crore including 50,000 equity shares at par at Rs. 10/- each along with assets and liabilities of Bhadla Ramgarh Power Transmission Limited as on the acquisition date (29.07.2026). However, the acquisition price is subject to adjustment as per the audited accounts of the Company as on the acquisition date.

Bhadla Ramgarh Power Transmission Limited is yet to start commercial operation, as such no turnover has been recorded during last 3 years. Bhadla Ramgarh Power Transmission Limited will be operating in India.
