We refer to our earlier letter dated 4th October, 2025, wherein we had informed that a search was being carried out by the Customs Department.

We now wish to inform you that the Company has received a Seizure Memo from the Customs Department. Accordingly, the said development is being intimated to the Stock Exchanges pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

iv	Details of the violation(s)/contravention(s) committed or alleged to be committed	<p>The test samples for the Imported goods were initially drawn for assessment and sent to Regional Fertilizer Control Laboratory (RFCL), Mumbai which undertakes only testing of fertiliser grade urea. Subsequently fresh samples were drawn by Customs authorities and sent to Central Revenues Control Laboratory (CRCL) New Delhi. As per the test report issued by CRCL, the Biuret content in the imported goods was found to be higher than the permissible limit. However, the Company has contested the testing methodology adopted by CRCL.</p> <p>It has been alleged that the Company appear to have violated the provision of DGFT notification No. 79/2015-2020 dated 18.03.2024 read with Foreign Trade Policy (FTP) and the goods appear to have contravened provisions of Customs Act, 1962 read with FTP.</p>
v	Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible	<p>Currently there is no material impact on financials or operations of the Company. The Company is taking appropriate legal recourse for Provisional Release of seized goods and use it exclusive for captive consumption as raw material in the manufacture of NPK fertilizers at our Goa plant. The Custom authorities are being persuaded to re-test the samples in accordance with procedure mandatorily required in terms of Para 3 read with Annexures A to H of Indian Standard IS 1781: 2022.</p>
