Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR"), read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 (as amended), we wish to inform you that the Board of Directors of Paradeep Phosphates Limited ("the Company"), at its meeting held today, has approved setting up an Aluminium Fluoride (AlF₃) Manufacturing Plant with a capacity of 15000 MTPA at Paradeep.

Industry or area to which the new line of business belongs	Industrial Chemicals – Fluorine Chemicals, specifically manufacture of Aluminium Fluoride (AlF ₃), utilizing Hydrofluorosilicic Acid (HFSA), a by-product generated during phosphoric acid production.
Expected benefits	The proposed project will enable value addition to HFSA by converting a low-value by-product into a high-value industrial chemical, diversify the Company's revenue streams into industrial chemicals, improve profitability and operating margins, strengthen fluorine management, support circular economy and sustainability initiatives, and create opportunities for future expansion into fluorine-based specialty chemicals.
Estimated amount to be invested	Approximately ₹250 Crores .
