Lamine Yamal Goes Viral After Palestine Gesture During Barcelona's Parade

Barcelona, (Agencies): Lamine Yamal once again found himself at the centre of attention — this time for a heartfelt gesture during Barcelona's La Liga title celebrations. During Barcelona's open-top bus parade on Monday, the 18-year-old winger was seen waving a Palestinian flag while celebrating with supporters across the city streets. Videos of the moment spread rapidly online, with many fans praising the youngster for expressing solidarity with Palestine amid the ongoing humanitarian crisis in Gaza. Since October 2023, Barcelona has also become one of Spain's most



giant centres for pro-Palestinian demonstrations, regularly hosting marches, rallies and humanitarian campaigns linked to Gaza. Tens of thousands of supporters flooded the streets of Barcelona as the Catalan

for only the second time in club history. Yamal adds More Fuel to Clasico Rivalry Earlier in the day, Yamal had already stirred social media with a pointed Instagram post following Barcelona's title-clinching win. The teenager uploaded a clip celebrating Ferran Torres' goal alongside the caption: "Talk is cheap", a line many fans interpreted as a subtle dig aimed at Jude Bellingham after earlier comments and celebrations during the season. And Yamal wasn't done there. During the parade, he was also spotted wearing a shirt reading: "Thank God I'm not a Madridista," a cheeky

jab at Barcelona's fierce rivals that instantly became another viral talking point online. Despite trailing Madrid earlier in the campaign, Hansi Flick's side produced a remarkable turnaround and now sit 14 points clear with three matches remaining.

Pakistan Allowed Iran To Park Military, Spy Aircraft While Mediating Talks: Report

Islamabad (AGENCIES): Pakistan denied the allegations, while Taliban officials also rejected claims that Iranian aircraft were being sheltered in Afghanistan. Despite positioning itself as a neutral party and mediator during the Iran-US conflict, Pakistan "quietly allowed" Iranian military and surveillance aircraft to park on its airfields, according to American officials quoted by CBS News. US officials told the broadcaster that Pakistan may have effectively shielded the aircraft from possible American airstrikes. However, Pakistan on Tuesday denied the CBS News report claiming Iranian aircraft at Nur Khan Airbase were linked to military activity. The Ministry of Foreign Affairs, Pakistan claimed the planes arrived during ceasefire talks to support diplomatic and administrative efforts involving Iran and the US. Islamabad stressed the aircraft had no military role and accused the report of spreading misleading speculation.



Pakistan in anticipation of subsequent rounds of engagement," reads Pakistan Foreign Affairs post on X. Meanwhile, Pakistan also said it remains committed to facilitating dialogue, peace and regional stability. "The Iranian aircraft currently parked in Pakistan arrived during the ceasefire period and bear no linkage whatsoever to any military contingency or preservation arrangement. Assertions suggesting otherwise are speculative, misleading, and entirely detached from the factual context. Pakistan has consistently acted as an impartial, constructive, and responsible facilitator in supporting dialogue and de-escalation," the statement further added. The US officials also claimed that Iran sent civilian aircraft to neighbouring Afghanistan, though it remains unclear whether any military aircraft were among those flights. According to the report, the aircraft movements appeared to be part of a broader Iranian effort to protect

remained parked at Kabul airport after Iran shut its airspace. The Afghan official further claimed that following Pakistani air raids on Kabul in March amid tensions with the Taliban government over alleged support for Tehrik-i-Taliban Pakistan (TTP), Taliban aviation officials decided to move the aircraft to Herat airport near the Iranian border for safety reasons and to avoid possible bombing of Kabul airport by Pakistani fighter jets. According to the official, it was the only Iranian aircraft left in Afghanistan. Taliban chief spokesman Zabihullah Mujahid denied the claims. "No, that's not true and Iran doesn't need to do that," Mujahid told CBS News. Islamabad appeared to be walking a diplomatic tightrope — projecting itself to Washington as a mediator and stabilising force while also trying not to alienate Tehran or China, Iran's most influential international ally.

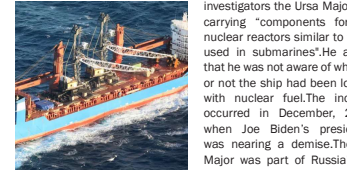

A Russian 'Ghost Ship' Sank In Mediterranean Under Mysterious Circumstances. What Was It Carrying?

Spain, (Agencies): A Russian cargo ship, allegedly carrying two nuclear reactors for submarines, came across a series of explosions and sank under unidentified circumstances, about 60 miles off the coast of Spain. According to a report by CNN, citing an investigation, the U.S. Major was likely headed to North Korea. The sinking of the ship under unknown circumstances marks a rare and significant intervention by a Western military to halt Russian nuclear aid to its key ally, North Korea. The ship set sail two months after North Korean leader Kim Jong Un had dispatched troops to assist Russia in its war against Ukraine.
