Dear Sir / Madam,

Pursuant to Regulation 30(4) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”) read with the Company’s Policy for Determination of Materiality, we wish to inform that Pranik Logistics Limited (the “Company”) has finalized and executed a definitive Master Service Agreement (“MSA”) on 30<sup>th</sup> June, 2026, with InstaKart Services Private Limited (the logistics arm of Flipkart group) (“InstaKart”). This agreement establishes the framework for the management of fulfillment centers or warehouses or delivery hubs operating from Bhagalpur, Bihar, including the storage and handling of products.

Considering the expected scale of operations, tenure of the engagement, business requirements communicated by InstaKart, and the anticipated revenue potential arising from the slab-based commercial framework, the Company has assessed that the arrangement qualifies as a material event in terms of Regulation 30(4) of the Listing Regulations.
