Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that Pranik Logistics Limited (the ‘Company’) has on 10<sup>th</sup> March 2026 entered into an agreement with Flipkart India Private Limited for the launch and operation of Twelve (12) HIH (Hub-In-Hub) facilities in the North and Eastern Regions of India.

**Brief particulars:**

- (a) **Parties:** Pranik Logistics Limited and Flipkart India Private Limited.
- (b) **Nature:** Commercial arrangement for launch, establishment and operation of HIH facilities (logistics and hub operations).
- (c) **Number & location:** Twelve (12) HIH facilities to be set up at mutually agreed strategic locations across the North and Eastern Regions of India.
- (d) **Effective date and tenure:** Agreement executed on 10<sup>th</sup> March 2026; tenure of the agreement is two (2) years unless earlier terminated in accordance with the agreement.
- (e) **Commencement:** The activities will be implemented in a phased manner; operations at individual HIH hubs will commence progressively at mutually agreed locations.
- (f) **Related party:** Not a related party transaction.
- (g) **Impact:** The said arrangement is in the ordinary course of business and is expected to be value-accretive and supportive of forward integration; the precise quantum of impact on revenue/profitability is not presently quantifiable.

This arrangement is in the ordinary course of business of the Company and is on arm’s length terms. This disclosure is being made in accordance with Regulation 30 of SEBI (LODR) Regulations, 2015.
