SMS Ltd lowest bidder for Kolshet, Kalher bridge

MUMBAI

The Mumbai Metropolitan Region Development Authority (MMRDA) has moved a step closer to awarding the contract for the proposed creek bridge connecting Kolshet and Kalher in Thane, with Nagpur-based SMS Limited emerging as the lowest bidder in the financial bid process.

According to bid results released on May 29, SMS Limited quoted ₹498.10 crore for the design and construction of the creek bridge project. The company's financial bid has been admitted for evaluation.

The project involves the design and construction of a creek bridge linking Kolshet and Kalher in Thane district, a key infrastructure proposal aimed at improving connectivity across the Mumbai Metropolitan Region. Following the financial evaluation, the authority is expected to complete the final scrutiny and issue a letter of award to the successful bidder after obtaining necessary approvals. Infrastructure major NCC Ltd emerged as the second-lowest bidder with ₹503.2 crore, while Aakshya Infra Projects Pvt Ltd secured the third position with a bid of ₹507.4 crore.

A total of five companies had participated in the tender process. However, the bids submitted by Ajwani Infrastructure and Gawar Construction were rejected at the technical evaluation stage.

The bridge is expected to enhance east-west connectivity in Thane and provide an additional crossing over the creek, helping ease traffic between the rapidly developing areas of Kolshet and Kalher.

Experts, citizens raise alarm over Thane Ring Metro Project

A coalition of residents, urban planning experts, and environmental advocates has placed the proposed Thane Integrated Ring Metro (TIIRM) under intense public scrutiny, citing severe planning discrepancies, financial risks, and ecological threats.

Operating under Citizens for Sustainable Transport (CST-Thane) and the Thane Green Collective, the groups have formally petitioned the state government to suspend the ₹12,200-crore project pending an independent review. The objections are backed by an evaluation from urban transportation planner Ashish Verma and urbanist Sulakshana Mahajan.

The 29km project projects a daily ridership of 6.47 lakh passengers by 2029. However, the

The citizen coalition has demanded that authorities immediately halt the project, wait for Metro Line 4 to become operational to assess actual travel patterns, and evaluate lower-cost alternatives like an expanded bus fleet, bus rapid transit (BRT), and suburban rail upgrades

expert review alleges critical flaws in its Detailed Project Report (DPR), including what the groups described as inappropriate transit choice, plagiarism and redundancy.

According to the review, the DPR forecasts a peak demand of 28,000 passengers per hour per direction (PPHPD) by 2050, a volume standard for Light Rail Transit (LRT) rather than a heavy metro system, which requires 30,000-50,000 PPHPD to justify its immense capital

costs. The groups have also alleged that Chapter 3 of the DPR refers to a mass transit system in Nagpur. Advocates argue this blatant copy-paste error indicates no Thane-specific willingness-to-travel survey was conducted. They further said the alignment duplicates existing infrastructure, intersecting Metro Line 4 and Line 5 with zero published inter-agency coordination.

The alignment also features an extreme 82 horizontal bends – compared to just 35-40 on Metro Line 4 – significantly inflating long-term maintenance costs. Additionally, the 3km downtown underground section lacks any published mobility contingency plan, risking a total surface transit collapse near Thane station during construction.

The Thane Green Collective has challenged official data regarding the project's eco-

logical footprint, revealing systemic data discrepancies. While the official DPR claims that 662 trees will be affected, the citizen survey found 3,224 trees marked for felling.

The DPR mentions nine heritage trees, while the citizen survey found 22 heritage trees in a 150-tree sample. The DPR claims there are zero century-old trees, while the citizen survey found 14. The audit also revealed that tree ages were systematically underestimated by an average of 28 years, and no comprehensive environmental impact assessment has been made public despite threats to the Thane Creek mangrove ecosystem.

Despite multiple attempts by The Free Press Journal, representatives from the Maharashtra Metro Rail Corporation (Maha Metro) did not respond to phone calls or emails before publication.

SBI employee, daughter killed in h'way crash

A 45-year-old State Bank of India employee and her 16-year-old daughter were killed after the family's car crashed into a stationary container truck on the Mumbai-Goa Highway near Hotel Balaji in Poladpur on Saturday afternoon. The deceased have been identified as Suvarna Markad, a senior associate with the bank's Dapoli branch, and her daughter Anushree. Suvarna's husband, Anil Raosaheb, 44, an employee of the Konkan Agricultural University in Dapoli, and their five-year-old son Chinmay sus-

tained serious injuries. Anil was shifted to a Mumbai hospital for advanced treatment, while Chinmay was admitted to a hospital in Mahad. The impact of the collision was severe, leaving the car completely mangled. The exact cause of the accident is being investigated, said assistant police inspector Anand Rawade. Police personnel, along with members of the Narveer Rescue Team and Kalbhairavnath Rescue Team, rushed to the scene after receiving information about the accident. A JCB machine was used to pull apart the wreckage and rescue the trapped occupants.

'Whistleblower' says he blew lid on Vashi stn work

Ex-employee of construction firm gets interim relief from HC after being accused of stealing documents

The Bombay High Court has granted interim protection from arrest to Shrikant Patil, 35, a former employee of a construction company, who claims that a theft case registered against him is an attempt to silence him for exposing misuse of public funds in the structural repair work of Vashi railway station between 2018 and 2020.

Vacation bench of Justice Sandesh Patil passed the order while hearing Patil's anticipatory bail application in connection with an FIR registered at Malad police station under the provisions of the Indian Penal Code.

According to the FIR lodged on October 17, 2025, by the chief MD of the company, Mahendra Realtors and

The case was filed by Mahendra Realtors and Infra against employee

Infrastructure Ltd, Patil had worked with the firm from 2016 until October 2018, initially as a driver and later as a sales executive. The complainant alleged that Patil stole company documents and used them to file a writ petition before the Bombay High Court.

Patil, however, has claimed that he is a "whistleblower" who approached the court through writ petition 9850 of 2024, seeking action against the company over alleged financial fraud in the project. His counsel argued before the court that the FIR had been registered to "pressurise the

applicant to withdraw the writ petition".

The bail application states that the documents relied upon in the petition have already formed part of court proceedings and that the complainant continues to possess the original records.

Patil had approached the HC after his plea was rejected by the sessions court. He contended that the rejection was influenced by a mistaken reference to an unrelated criminal case involving another person with a similar name. The public prosecutor sought time to take instruction.

While granting protection, the HC directed his release, in case of arrest, on bail on furnishing a personal bond of Rs20,000. The court also directed him to cooperate with the investigation whenever required.

THANE: A memorial dedicated to the revered queen Ahilyadevi Holkar was inaugurated in Thane on Saturday, marking her 301st birth anniversary. The event was organised by Dhargar Pratishtan and attended by several dignitaries, social activists, office-bearers and members of the Dhargar community.

Deputy Chief Minister Eknath Shinde said the state government was drawing inspiration from Ahilyadevi Holkar's ideals of welfare, development and public service.
