No announcement has been made by the Company/Management/ promoters about change in profitability/sales and/or book order position of the company. Hence this can not be the reason for increase in price and volume of the shares.

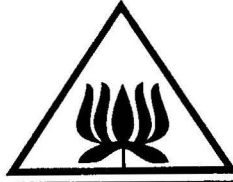
