With reference to your email regarding deficiency/ non-submission of the details/ documents in relation to the Financial results for the quarter ended 30<sup>th</sup> June, 2023, please find the following thorough detailed reply for the purpose of clarification:

**Query 1: Segment details not submitted**

**Reply:** As you are aware that the Hon'ble NCLT, Mumbai bench vide its order dated 29th January, 2021 in C.P. (I.B) No.1224/MB/2020, has initiated Corporate Insolvency Resolution Process ("CIRP") against Premier Limited ("Corporate Debtor") under the provisions of Insolvency and Bankruptcy Code, 2016 ("Code").

The Company did not have any business operations since before admission to insolvency on 29-01-2021 onwards to till date. Therefore, the segment details are not possible to be submitted due to non-operations and non-existence of business operations for the quarter ended 30.06.2023 was not furnished.

**Query 2: Financial results not submitted within 30 minutes from end of board meeting.**
