Sub: Administrative Warning in relation to disclosure made in the offer document of Presstonic Engineering Limited

Madam,

1. This has reference to the disclosure made in the offer document of Presstonic Engineering Limited ("the Company") in respect of track record of one of the directors of the Company- Ms. Kodipadi Yerkadithaya Supriya Murthy.
2. In this regard, it is noted that while you were convicted by the Hon'ble Court in 2015 in the matter pertaining to cheque bouncing, you had submitted incorrect information to the Lead Manager to the Issue that there are nil litigations against you involving criminal/civil matters. Further, the offer document contained a certificate signed by you that that all disclosures made in the offer document are true and correct.
3. Therefore, it appears that the offer document did not contain true and adequate disclosure in respect of track record of the director of the Company, as envisaged in the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018 ("ICDR Regulations").
4. Hence, by providing a certification that all the statements made in the offer document are true and correct, you are not in compliance the provisions of Regulation 245(2)(b) of ICDR Regulations *read with* Para 12 and Para 18 (5) of Part A of Schedule VI of ICDR Regulations.





5. Above non-compliance has been viewed seriously and you are hereby warned and advised to be careful in future to avoid recurrences of such lapses. Any repetition of the same violation in future will be viewed seriously and appropriate enforcement action would be initiated in accordance with the provisions of the SEBI Act, 1992, the rules or the regulations issued thereunder.
