Please note that the Fund Raising Committee of the board of directors of the Company (the "**Committee**") has, at its meeting held today i.e. September 5, 2024 approved the issue and allotment of 2,98,68,578 Equity Shares to eligible qualified institutional buyers at an issue price of  $\gtrless$  1,674 per Equity Share (including a premium of  $\gtrless$  1,664 per Equity Share) [(which includes a discount of  $\gtrless$  81.09 per Equity Share (4.62% of the floor price, as determined in terms of the SEBI ICDR Regulations)] against the floor price of  $\gtrless$  1,755.09 per Equity Share, aggregating to  $\gtrless$  5,000 crores (Rupees Five Thousand Crores only), pursuant to the Issue.

The Issue opened on August 29, 2024 and closed on September 4, 2024 and the same was intimated to you through our letters dated August 29, 2024 and September 4, 2024 respectively.
