Subject: Clarification on Outcome of Board Meeting Financial Results submitted to the Exchange dated 22-Apr-2026

Dear Sir/Madam,

We would like to clarify that the Prizor AITECH India Limited (“PAIL”) has ceased to be a subsidiary of Prizor Viztech Limited (“PVL”) with effect from March 30, 2026. The cessation is on account of a preferential issue of equity shares undertaken by the said entity, wherein the Company has not subscribed to such issuance. Consequently, the shareholding of PVL in PAIL has been diluted and has fallen below 51%, resulting in loss of control and the entity no longer qualifying as a subsidiary of the Company. The company had also intimated NSE on March 30, 2026, through Corporate Announcements.


However as per NSE requirements, the company submit the consolidated financial results on or before May 30, 2026.
