We were appointed as statutory auditors of Atyati Technologies Private Limited ("the Company") in 17th Annual General Meeting ("AGM") held on September 29, 2022 for a period of 5 years till the conclusion of 22nd AGM.

Further to our various discussions and your email dated September 24, 2026, we understand that there has been a change in the ownership of the Company from Geosansar Mauritius Limited to BLS E-Services Limited w.e.f. July 2, 2026. As informed, certain non-audit services are being provided by another member firms of Ernst & Young Global Limited to BLS E-Services Limited and BLS International Services Limited (Holding Company of BLS E-Services Limited). In this circumstance, we will not be able to continue as statutory auditor of the Company under our internal independence requirements and accordingly, we hereby tender our resignation as the statutory auditors of the Company and request you to treat this as our letter of resignation with immediate effect. We have also discussed this matter with the Management of the Company.
