Sub.: Clarification in response to Query on Outcome of Board Meeting – Financial Results submitted on 20 May 2026

Dear Sir/Madam,

This is with reference to your email regarding the Outcome of Board Meeting – Financial Results submitted by **P. E. Analytics Limited** on **20 May 2026**. We hereby submit our point-wise clarification as under:

1. Financial Results submitted in XBRL with discrepancies

(a) Paid-up Equity Share Capital mentioned in actuals and not in the denomination selected by the Company in XBRL

We wish to submit that, while preparing the XBRL filing, the Paid-up Equity Share Capital was inadvertently reported in its actual value instead of the denomination/unit selected in the XBRL utility. This resulted in the discrepancy observed by the Exchange. We confirm that the Financial Results approved by the Board and submitted in PDF format were correct and there was no discrepancy in the approved financial statements. The XBRL filing has since been revised by incorporating the correct denomination.

(b) Mismatch in PAT figures mentioned in Consolidated XBRL and PDF

The mismatch in the PAT figures in the Consolidated XBRL was a consequential outcome of the above inadvertent error in reporting the denomination while preparing the XBRL filing. We confirm that the PAT figures disclosed in the Board-approved Financial Results submitted in PDF format were correct. The revised XBRL has been filed to ensure complete consistency between the XBRL filing and the approved Financial Results.

2. The Company has not submitted declaration in case of unmodified opinion

The Declaration pursuant to Regulation 33(3)(d) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, in respect of the unmodified audit opinion could not be uploaded along with the original submission due to an inadvertent oversight.

The said declaration is enclosed herewith as "Annexure A" for your kind record.
