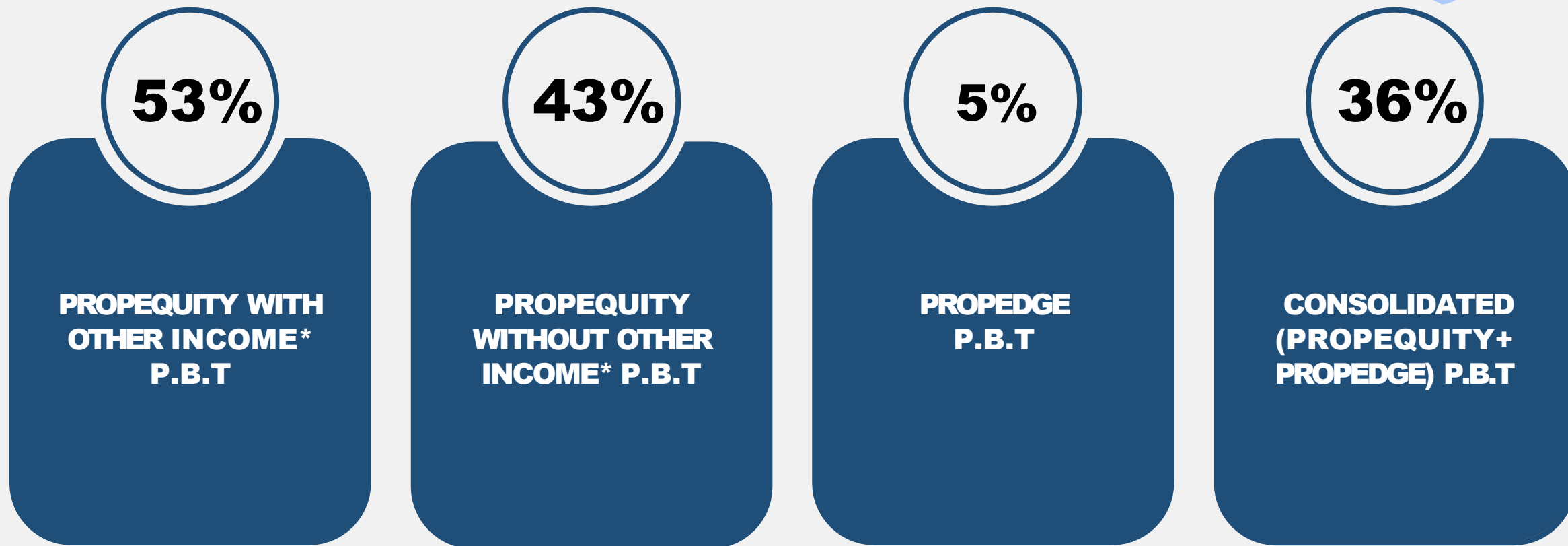

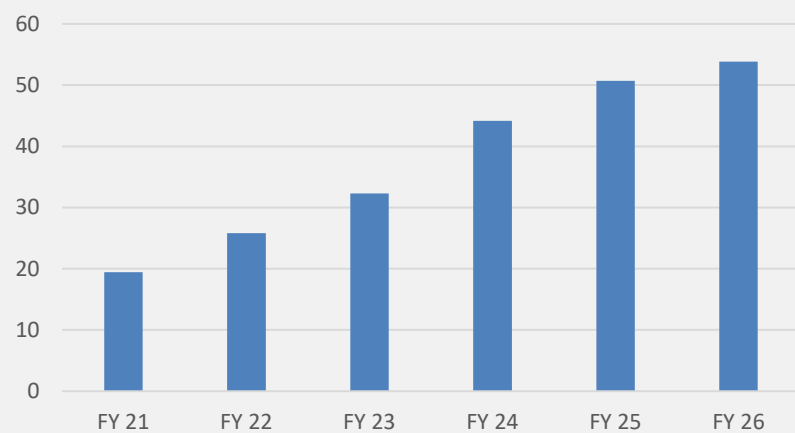

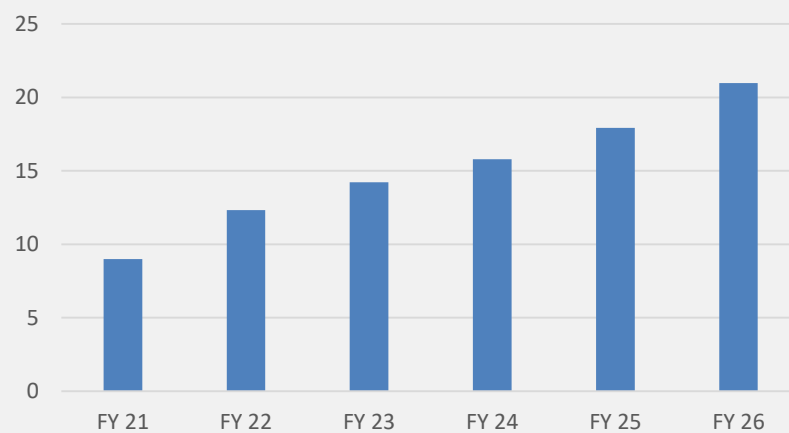

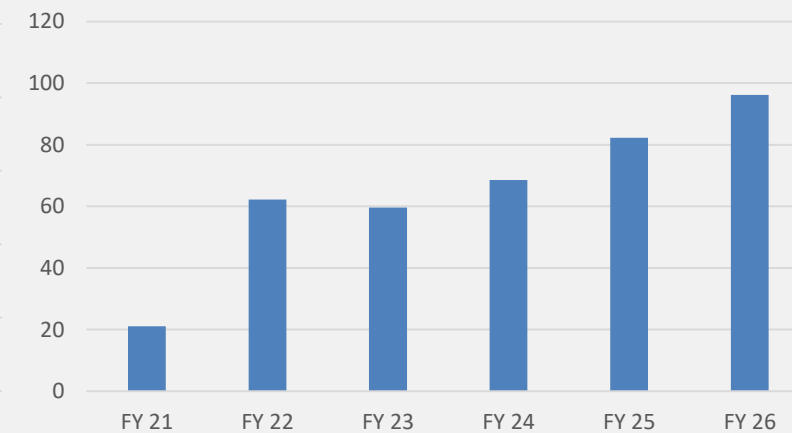
Revenue Growth (177%)
