सौंदर्य और फैशन क्षेत्र की रिटेल कंपनी नायिका की मूल कंपनी एफएसएन ई-कॉमर्स वेंचर्स लिमिटेड को उम्मीद है कि वित्त वर्ष 2026 की चौथी तिमाही (जनवरी-मार्च) में उसका संयुक्त शुद्ध राजस्व पिछले वर्ष की तुलना में 20 प्रतिशत बढ़ेगा। यह पिछली 12 तिमाहियों में उसकी सबसे अधिक वृद्धि होगी। इस सूचना के बाद कंपनी के शेयर की कीमत शुरुआती कारोबारी में 3 प्रतिशत बढ़ गई। यह शेयर 252.65 रुपये पर बंद हुआ जो पिछले दिन के बंद भाव से 2.72 प्रतिशत अधिक है।

सोमवार को एक्सचेंज को दिए गए अपडेट में कंपनी ने कहा, 'कुल शुद्ध राजस्व में करीब 20 प्रतिशत इजाफे की उम्मीद है, जो पिछली 12 तिमाहियों में सबसे अधिक वृद्धि होगी। यह मजबूत प्रदर्शन फैशन और सौंदर्य क्षेत्र में अच्छे प्रदर्शन के कारण हुआ है।' कंपनी ने यह भी कहा कि संयुक्त मर्चेंडाइजिंग (जीएमवी) में वृद्धि 20 प्रतिशत के करीब होगी, जबकि शुद्ध बिक्री वैल्यू (एनएसवी) में बढ़ोतरी 30 प्रतिशत के शुरुआती दायरे के करीब रहने की उम्मीद है।

देश में वाहनों की खुदरा बिक्री के लिहाज से वित्त वर्ष 26 अब तक का सर्वश्रेष्ठ वर्ष रहा। इस वर्ष वाहनों की छह में से पांच श्रेणियों में रिकॉर्ड वार्षिक बिक्री दर्ज की गई। इससे वाहनों की कुल बिक्री 3 करोड़ के करीब पहुंच गई, जो वित्त वर्ष 25 की तुलना में 13 प्रतिशत अधिक है। फेडरेशन ऑफ ऑटोमोबाइल डीलर्स एसोसिएशंस (फाडा) के आज एक बयान में इस बारे में आंकड़े साझा किए। इनके अनुसार यह शानदार प्रदर्शन मुख्य रूप से वस्तु एवं सेवा कर (जीएसटी) 2.0 की लचीली की बदौलत हुआ।

यात्री वाहनों ने पहली बार 47 लाख का आंकड़ा पार किया और 13 प्रतिशत की बढ़ोतरी दर्ज की गई। दोपहिया वाहनों ने फिर से कोविड से पहले वाला शीर्ष स्तर हासिल कर लिया और 13.4 प्रतिशत वाहनों की खुदरा बिक्री की। वाणिज्यिक वाहनों ने भी अब तक के सर्वश्रेष्ठ आंकड़े दर्ज किए और 11.74 प्रतिशत की बढ़त के साथ 10 लाख से ऊपर का स्तर छुआ। तिपहिया वाहनों ने 11.68



वित्त वर्ष 26 में वाहनों की 6 में से 5 श्रेणियों में रिकॉर्ड वार्षिक बिक्री दर्ज की गई और इससे वाहनों की कुल बिक्री 3 करोड़ के करीब पहुंच गई

प्रतिशत के इजाफे के साथ लगातार तीसरे वर्ष वार्षिक रिकॉर्ड बनाया। ट्रैक्टर इस साल बेहतर प्रदर्शन करने वाली श्रेणी रही। इस श्रेणी ने 18.95 प्रतिशत की बढ़त के साथ इतिहास में पहली बार 10 लाख की खुदरा बिक्री का आंकड़ा पार किया। निर्माण उपकरण श्रेणी एकमात्र अपवाद रही, जिसमें 11.70 प्रतिशत की गिरावट दर्ज की गई। ऐसा इसलिए हुआ क्योंकि परियोजना-

यह ऐसी उपलिब्ध है, जो दो साल पहले दूर की बात लग रही थी। इस साल को जो बात विशेष रूप से अहम बनाती है, वह यह है कि वृद्धि संरचनात्मक रूप से मजबूत थी, जो खर्च उठाने की बेहतर क्षमता, शहरी और ग्रामीण भारत में परिवहन की बढ़ती मांग तथा मिलेजुले इंजनों के मिश्रण पर आधारित थी।' उद्योग का यह संगठन दो अंकों में वृद्धि की उम्मीद कर रहा है।

अलबत्ता यह साल समान रफ्तार वाला नहीं था। पहले पांच महीने यानी अप्रैल से अगस्त तक की अवधि सुस्त रफ्तार वाली थी। इसमें मासिक वृद्धि 2 से 5 प्रतिशत के बीच रही, क्योंकि बाजार पिछले वर्ष के स्टॉक के सुस्त चक्र, चुनिंदा वित्तीय सहायता की बाधाओं और नौतिगत स्पष्टता की कमी में ग्राहक का प्रतीक्षा एवं समीक्षा वाला रुख रहा।

सितंबर में जीएसटी 2.0 के कार्यान्वयन के साथ अहम मोड़ आया। विघ्नेश्वर ने कहा, 'दर में सुधार ने बड़े स्तर पर दोपहिया वाहनों, छोटी कारों, तिपहिया और चुनिंदा वाणिज्यिक श्रेणियों पर प्रभावी कर बोझ को काफी कम कर दिया। उसने ऐसे समय खर्च उठाने की वास्तविक क्षमता में सुधार किया, जब उपभोक्ता पहले से ही इसके लिए तैयार था।'

सोने में नरमी के बीच बढ़ी शादियों के लिए खरीदारी : टाइटन

शालीन डिस्ज्जा मुंबई, 6 अप्रैल

टाइटन के आभूषण डिवीजन में पिछले साल के मुकाबले सोने की ऊंची कीमतों के बावजूद ग्राहकों की लगातार दिलचस्पी देखी जा रही है। कंपनी ने यह भी गौर किया कि सोने की अधिक कीमतों के कारण उसके 50 प्रतिशत ग्राहक पुराने आभूषणों से अदला-बदली कर रहे हैं। सोने की कीमतों में हालिया नरमी ने अक्षय तृतीया के दौरान आगामी शादी-विवाह के सीजन के लिए सोने के आभूषणों की मांग को भी बढ़ा दिया है।

टाइटन ज्वैलरी के मुख्य कार्य अधिकारी अरुण नारायण ने बिजनेस स्टैंडर्ड के साथ बातचीत में कहा, 'पिछले दो से तीन महीने के दौरान हमने ग्राहकों को हमारे स्टोर्स में आने देखा है क्योंकि खरीदारी थोड़ी पहले हो रही है। आम तौर पर अक्षय तृतीया के बाद शादी-विवाह का जोरदार सीजन रहता है। हम यह भी देख रहे हैं कि लोग अपनी

खरीदारी पहले ही कर लेने की कोशिश में हैं और सोने की कीमतों में फिर से इजाफे का जोखिम नहीं ले रहे हैं। हम उन लोगों की भी अधिक रुचि देख रहे हैं जो अक्षय तृतीया के दौरान छोटी खरीदारी करना चाहते हैं, क्योंकि इसे सोना खरीदने की बहुत शुभ माना जाता है।'

हालांकि नारायण ने यह नहीं बताया कि मांग में कितनी वृद्धि हो सकती है या बढ़ सकती है। लेकिन उन्होंने कहा कि सोने के खरीदार (जो सोने में निवेश करना चाहते हैं) भी पिछले साल की तुलना में बढ़ गए हैं।

उन्होंने कहा, 'हम अशर्फी में अच्छा इजाफा देखेंगे। पिछले साल भी यही चलन रहा है। ये वास्तव में निवेश वाले खरीदारों के लिए होती हैं। हम आभूषणों को सुलभ बनाए रखने के लिए कई पहल कर रहे हैं। इसमें सोने के जेवरत और 18 कैरेट के साथ हल्के वजन वाले आभूषण भी शामिल हैं। पिछले छह महीने के दौरान इन्होंने अच्छा जोर पकड़ा है।'
