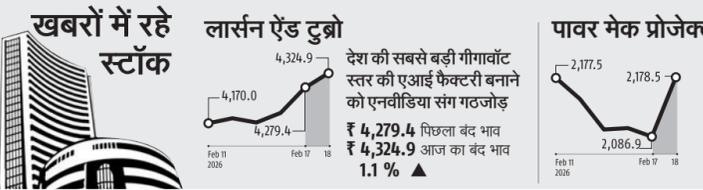

इन इंडिया एलएलएम

इंडियन एआई स्टार्टअप सर्वम ने बुधवार को दो देसी बड़े लैंग्वेज मॉडल (एलएलएम) पेश किए, जिन्हें खास तौर पर भारतीय भाषाओं पर प्रशिक्षित किया गया है, क्योंकि एलएलएम निर्माता लोगों द्वारा बोली जाने वाली भाषाओं के लिहाज से दुनिया में सबसे विभिन्नताओं वाले देश में मुकाबला कर रहे हैं। इस घोषणा में 30 अरब और 105 अरब पैरामीटर वाले मॉडल शामिल हैं। पहला मॉडल 32,000 कॉन्टेक्ट विंडो के साथ रियल टाइम बातचीत का प्रबंधन करता है, जिससे इन्फर्मेंसिंग की लागत बहुत कम हो जाती है, जबकि दूसरे में ज्यादा जटिल कार्यों के लिए 1,28,000 टोकन हैं।

एआई इम्पैक्ट समिट में बना गिनीज वर्ल्ड रिकॉर्ड

इंडिया एआई इम्पैक्ट समिट 2026 ने 24 घंटे के भीतर छात्रों से एआई के जिम्मेदार उपयोग के लिए सर्वाधिक संख्या में प्रतिबद्धताएं हासिल करने का रिकॉर्ड बनाते हुए 'गिनीज वर्ल्ड रिकॉर्ड्स' में अपना नाम दर्ज कराया है। ब्रिटिश रिकॉर्ड संस्था ने बुधवार को यह जानकारी दी। 'गिनीज वर्ल्ड रिकॉर्ड्स' के अधिनिर्णायक प्रवीण पटेल ने घोषणा की कि सम्मेलन के दौरान कुल 2,50,946 प्रतिबद्धताएं हासिल हुईं जबकि लक्ष्य केवल 5,000 का था।

मेटा जैसी कंपनियों के लिए सबसे बड़ी चुनौती कंटेंट हटाने के लिए घटाई गई तीन घंटे की टाइमलाइन को लागू करते समय असली कंटेंट और खतों के साथ-साथ ऐसे कंटेंट की संभावना है जिसे कोर्ट के आदेश या किसी सरकारी अधिकारी के आदेश पर हटाने के लिए कहा गया हो। मेटा में पॉलिसी के उपाध्यक्ष एवं उप मुख्य निजता अधिकारी रॉब शर्मन ने यह बात कही।

शर्मन ने मौजूदा एआई इम्पैक्ट समिट के मौके पर एक मीडिया राउंडटेबल में कहा, 'जब भी हमें सरकार से किसी कंटेंट की जांच करने का अनुरोध मिलेगा, हम खुद उसकी जांच करेंगे और उसे विलेट्टे करेंगे। इसमें बस समय लगता है। अक्सर तीन घंटे में काम पूरा करना मुमकिन नहीं होता।'

पिछले सप्ताह, इलेक्ट्रॉनिक्स और सूचना प्रौद्योगिकी मंत्रालय ने इन्फॉर्मेशन



टेकनॉलजी (इंटरमीडियरी गाइडलाइंस और डिजिटल मीडिया एथिक्स कोड) नियमों में बदलावों को नोटिफाई किया, जिसके तहत यह जरूरी किया गया कि सोशल मीडिया और इंटरनेट इंटरमीडियरीज को अब संदिग्ध कंटेंट को तीन घंटे के अंदर हटाना होगा, जबकि अभी तक यह समय 36 घंटे था। नए नियम शुक्रवार से लागू हो गए हैं।

उन चुनौतियों को बताने की कोशिश कर रही है जिनका सामना कंपनियों को करना पड़ सकता है। उन्होंने यह भी कहा कि मेटा के पास डिजिटल पर्सनल डेटा प्रोटेक्शन एक्ट के नियमों और गाइडलाइंस का पालन करने के लिए एक 'काफी मैच्योर प्रोग्राम' है।

शर्मन ने कहा, 'आमतौर पर, जब नए प्राइवसी नियम अपनाए जाते हैं, तो टाइमलाइन लगभग दो साल की होती है। भारत सरकार ने टाइमलाइन को काफी कम कर दिया है। हम अभी भी यह देखने की प्रक्रिया में हैं कि इसका क्या मतलब होगा।' पिछले साल नवंबर में अधिसूचित किए गए डीपीडीपी नियमों ने भारत के पहले बड़े डिजिटल प्राइवसी कानून को लागू किया, जिस पर एक दशक से ज्यादा समय से अलग-अलग रूपों में चर्चा चल रही थी। नवंबर में, केंद्रीय आईटी मंत्री अश्विनी वैष्णव ने कहा था कि सरकार डीपीडीपी ऐक्ट के अंतर्गत अनुपालन समय-सीमा 18 महीने से घटाकर 12 महीने करने के लिए उद्योग हितधारकों के साथ बातचीत कर रही है।

माइक्रोसॉफ्ट करेगी 50 अरब डॉलर कानिवेश

डेमिस हसाबिस ने कहा कि मौजूदा प्रणालियों में सीखने की सामान्य क्षमता की कमी है। यानी तैनाती के बाद भी सीखते रहने की क्षमता।

अल्फाबेट और गूगल के मुख्य कार्याधिकारी सुंदर पिचाई ने बुधवार को इंडिया अमेरिका केनैक्ट इनिशिएटिव की घोषणा की। यह एक नया इन्फ्रास्ट्रक्चर है जो अमेरिका और भारत के बीच एआई कनेक्टिविटी बढ़ाएगा। यह संपर्क दक्षिणी गोलार्ध में कई स्थानों पर नए सब-सी यानी समुद्र की नीचे केबल रूट के जरिये मिलेगा।

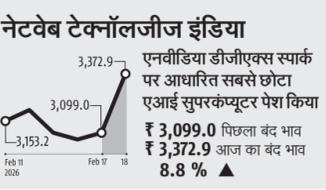
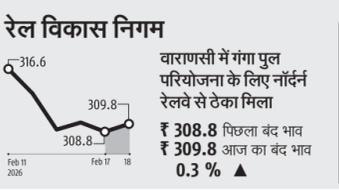
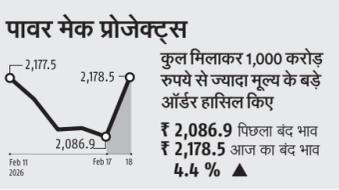

मेटा जैसी कंपनियों के लिए सबसे

बड़ी चुनौती कंटेंट हटाने के लिए घटाई गई तीन घंटे की टाइमलाइन को लागू करते समय असली कंटेंट और खातों के साथ-साथ ऐसे कंटेंट की संभावना है जिसे कोर्ट के आदेश या किसी सरकारी अधिकारी के आदेश पर हटाने के लिए कहा गया हो। मेटा में पॉलिसी के उपाध्यक्ष एवं उप मुख्य निजता अधिकारी रॉब शर्मन ने यह बात कही।

शर्मन ने मौजूदा एआई इम्पैक्ट समिट के मौके पर एक मीडिया राउंडटेबल में कहा, 'जब भी हमें सरकार से किसी कंटेंट की जांच करने का अनुरोध मिलेगा, हम खुद उसकी जांच करेंगे और उसे विलेट्टे करेंगे। इसमें बस समय लगता है। अक्सर तीन घंटे में काम पूरा करना मुमकिन नहीं होता।'

पिछले सप्ताह, इलेक्ट्रॉनिक्स और सूचना प्रौद्योगिकी मंत्रालय ने इन्फॉर्मेशन

माइक्रोसॉफ्ट करेगी 50 अरब डॉलर का निवेश

सॉफ्टवेयर क्षेत्र की दिग्गज कंपनी माइक्रोसॉफ्ट ने बुधवार को कहा कि वह विकासशील देशों में एआई ढांचा और क्षमताओं का विस्तार करने के लिए दशक के अंत तक 50 अरब डॉलर का निवेश करने की राह पर है।

'8 अरब से अधिक लोगों के लिए स्केलिंग ट्रस्टेड एआई' विषय पर मुख्य भाषण देते हुए माइक्रोसॉफ्ट के अध्यक्ष ब्रैड स्मिथ ने कहा कि विकसित और विकासशील देशों के बीच असमानता है। लेकिन एआई इस अंतर को पाटने में मदद कर सकता है, जिससे विकासशील देशों को आर्थिक वृद्धि पर पकड़ बनाने में मदद मिलेगी।

उन्होंने कहा, 'हमें वह इन्फ्रास्ट्रक्चर लाने की जरूरत है जिसकी विकासशील देशों को आवश्यकता है। इसका मतलब है डेटा सेंटर, कनेक्टिविटी और बिजली। यही कारण है कि सत्य नडेला ने घोषणा की कि माइक्रोसॉफ्ट भारत में 17 अरब डॉलर खर्च करेगी। इसीलिए हम दशक के अंत तक एआई को यहां लाने के लिए 50 अरब डॉलर खर्च करने की दिशा में तेजी से बढ़ रहे हैं।' पिछले साल दिसंबर में कंपनी ने घोषणा की थी कि वह भारत में क्लाउड और एआई इन्फ्रास्ट्रक्चर, कौशल विकास और अन्य कार्यों को आगे बढ़ाने के लिए 2026 और 2029 के बीच 17.5 अरब डॉलर का निवेश करेगी। यह घोषणा पिछले साल जनवरी में घोषित 3 अरब डॉलर से अलग थी।

माइक्रोसॉफ्ट की एआई डिफ्यूजन रिपोर्ट के डेटा का

हवाला देते हुए स्मिथ ने कहा कि विभिन्न क्षेत्रों के बीच एआई को अपनाने में असमानता है। उन्होंने कहा, 'जेनरेटिव एआई की महान कहानी केवल तीन साल और तीन महीने पहले तब शुरू हुई थी जब जीपीटी जारी किया गया था। हम शुरूआती वर्षों में हैं लेकिन ये शुरूआती साल पूरी तरह से ठीक नहीं चल रहे हैं। 2025 की दूसरी छमाही में विकसित देशों में काम करने वाली 25 प्रतिशत आबादी एआई का उपयोग कर रही थी, लेकिन विकासशील देशों में यह केवल 14 प्रतिशत थी। यह नया फासला है और यह ठीक होने के बजाय विगड़ता जा रहा है।'

शिक्षा और कौशल विकास के मामले में स्मिथ ने कहा कि विकासशील देशों में एआई कौशल की आवश्यकता है और भारत इस गतिविधि का केंद्र बिंदु है।

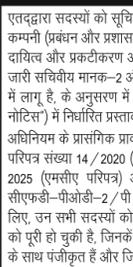
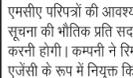
