Further to the Media Release titled “RELIANCE CONSUMER PRODUCTS ACQUIRES TAMIL NADU’S SOUTHERN HEALTH FOODS” submitted today (copy of which is attached herewith), we wish to inform that:

1. Reliance Consumer Products Limited (RCPL), a subsidiary of the Company, has acquired 100% equity stake in Southern Health Foods Private Limited (SHFPL) for an aggregate cash consideration of Rs. 156.42 crore from existing shareholders of SHFPL. Consequently, SHFPL has become a wholly owned subsidiary of RCPL effective February 9, 2026.
2. SHFPL was incorporated on April 16, 2012. The turnover of SHFPL for the FY2024-25, FY2023-24 and FY2022-23 was Rs. 109.40 crore, Rs. 127.37 crore and Rs. 126.65 crore, respectively.
3. The transaction is not a related party transaction and none of the Company’s promoter / promoter group / other group companies have any interest in the above transaction.
4. No governmental or regulatory approvals were required for the above transaction.
